Re: Admiration for Ronald Reagan

Rush—just reviewed your latest (9/14) *Limbaugh Letter*. Bravo! Your analysis of “power-mad freaks who brook no opposition” and “Obama’s goal is to transform the country” fits Ronald Reagan’s philosophy.

You and I share reverence for Mr. Reagan. His great, perhaps greatest, speech was *A Time for Choosing* (1964). He said, “. . . up to man’s age-old dream, the maximum of individual freedom, consistent with order, or down to the ant heap of totalitarianism.”

That choice finds an analytical framework that I believe incorporates your thinking and guides evaluation of any public policy, politician’s position, or pundit pronouncement. At the risk of appearing immodest, I label this thought-guiding tool the **Enis Analytical Framework (EAF)**. See if these examples incorporate your thinking and guide analysis:

The world is divided into two kinds of people: those who desire to tell other people what to think and say and do (totalitarians), and those who resist such orders (freedom-seekers). To avoid any current connotations—left-wingers, radicals, out-of-the-mainstream, conservatives, tea-partiers, etc.—let’s label the former **TOTALISTS** and the latter **FREEDOMITES**. **TOTALISTS** are Platocrats—followers of the philosophy that sees the world as it ought to be (*Plato’s Republic*)—idealism structured by ideology. **FREEDOMITES** follow Aristotle (*Politics*) who says see the world as it is—common experience structured by science and evidence.

Totalitarianism has many labels: aristocracy, feudalism, socialism, fascism, communism, communitarianism, liberalism (20th century version), progressivism. **TOTALISTS** believe that their desires rule slaves, peasants workers, proletariat, untermenshen, useful idiots, rank-and-file union members, American consumers. The elite few not only know what is best, but fervently believe that that knowledge grants them the power to force the rest of us to obey. Thus they seek ever more rules, laws, regulations, tax increases to enforce and expand their powers. We know what is best for you—even if you do not comprehend or acquiesce. You are not only ignorant, but are evil, to oppose us **FREEDOMITES**.

The **EAF** not only categorizes schools of philosophy, but also economics: micro (price) theory studies how individuals (who resist being told what to do) respond to incentives—in most basic form: supply/demand changes to price adjustments. Macroeconomics studies how public policy (monetary and fiscal) promulgated by politicians and bureaucrats affects economic

behavior. Price theory has developed from Adam Smith to Alfred Marshall to Ludwig von Mises to Milton Friedman to Gary Becker and Steven Levitt. Macro theory—public policy descends from Thomas Malthus to Chancellor Bismarck to Lord Keynes to Thomas Piketty and Paul Krugman. Note how the emphasis of analysis shifts from micro to macro: individual behavior to government control.

We can use the **EAF** to analyze public policy today: Obama’s war on business (EPA, FDA, renewable energy, Obamacare), IRS political targeting, Bengasi tragedy, ignored red line in Syria, illegal immigrant amnesty, faux impeachment scare, and on and on. Given that TOTALISTS “cannot fathom how many millions of Americans resent the hell out of what they’re doing, how are they “about to find out”? How do those of us who favor individual freedom—initiative and entrepreneurship, the Constitution, small and efficient government, religious freedom, etc. analyze and act to prevent TOTALISTS from transforming it?

The **EAF** can begin to structure that thought and action. It is not an answer, but a blueprint, a balance sheet, for guiding analysis. Just as an architect’s blueprint or an accountant’s balance sheet structures their work, so can the **EAF** structure analysis of public policy. It does not relieve the analyst of hard thought about each policy or politician, but does provide structure and guidance for that analysis.
